## Code de Vie Pandemic COVID 19 Parent Agreement

Please take the time to read this Code de Vie – Pandemic Covid 19 Parent Agreement.

This agreement includes the new procedures to bring your child to CPE Vanier. These new procedures are necessary as we reopen our CPE during the Covid 19 pandemic and, supports us in ensuring that we are taking precautions in providing a safe environment for the staff members and the children attending our CPE.

### THE AGREEMENT:

1. During this pandemic I will not be permitted to enter CPE Vanier beyond the designated drop-off and pick-up area(s). I understand that this procedure is to help ensure the overall safety of the children and adults present in the daycare, in the hopes of limiting everyone's risk of exposure.
2. The drop-off and pick up process in the morning and afternoon may take longer now considering the following changes: lining up with a distance of 2 meters apart and dropping off your child at the exterior entrance where one of the staff members will greet your child to bring them into the daycare.
3. I am responsible to ensure the pickup and drop-off person will be the same person whenever possible; others are equally responsible to follow the protocol.
4. I understand that in order to enter CPE Vanier my child must be symptom-free from COVID-19. If, during the day, any of the following symptoms arise, my child will be separated from everyone else. I will be asked to pick up, and we agree to do so within 30 minutes of being notified. Symptoms may include: Fever 38° C / 100° F, runny nose, rash or diarrhea, dry or wet cough, shortness of breath, chills, loss of taste or smell, sore throat, muscle aches, sleepy or any other symptoms that may be associated with a virus.
5. While I understand that many of these symptoms can also be related to other viruses, I must proceed as if my child has contracted COVID-19. The symptoms usually appear 2-7 days after being infected.
6. If my child is ill, they MUST be symptom-free without taking any medications for 48 consecutive hours after the symptoms no longer appear before being allowed to return to the CPE.
7. If my child returns to the daycare and is still occasionally coughing, or displays other mild symptoms, they will be quarantined.
8. My child will be required to wash their hands with soap and water many times during the day. I will help facilitate this by practicing with them at home regularly.
9. Outside of the daycare, I will comply with any government rules regarding socializing (social distancing, etc.) and control my child's exposure within the community as much as possible. If I must (travel?) for emergency reasons, I will notify the CPE upon my next arrival.

10. My child and I will only gather as per government rules and we will all practice social distancing and minimize exposure as much as possible.
11. I will immediately notify CPE Vanier administration if I become aware of anyone with whom my child or I have had contact with exhibits any symptoms of the virus.
12. I will immediately notify CPE Vanier administration if anyone from my place of employment is presumed positive, is in quarantine or tests positive for the virus, whether I have had direct contact with that person or not.
13. I understand that while at daycare, my child will be in contact with other children and adults who are also at risk. I understand that the contents of this protocol and all other restrictions and guidelines DO NOT guarantee my child's health.
14. I understand that I play a crucial role in keeping my child and everyone else entering the CPE safe and reducing the risk of exposure.
15. I agree to only bring the items that are needed by the CPE such as extra clothing and that no other personal items of my child will be brought to the CPE such as i.e. personal toys, dodo's, bed sheets.
16. I understand that the CPE will provide bed sheets that will be washed at the CPE and comfort toys for my child.
17. I understand that for hygiene reasons I must provide a pair of indoor shoes for my child that will be kept at the CPE until they need a new pair.
18. I agree to always respect the socializing rules of 2 meters apart when around other parents outside the premises of the daycare (playground/parking lot).
19. I will help my child practice the correct way of sneezing and coughing at home (into their arm/elbow) and help them to understand what it means to stay away from others.
20. I agree not to hold the daycare or any of its employees responsible should either my child or myself become ill.
